Contra Costa Waste Services (CCWS), also known as the Recycling Center & Transfer Station (RCTS), is a full-service facility, located at 1300 Loveridge Road in Pittsburg, is open 7 days a week, from 7 am to 6 pm. Closed on Christmas and New Year's Day only.



RCTS is Now Accepting Treated Wood Waste!

CCWS is a permitted facility. The Department of Toxic Substances Control and the State of California, require that each customer must provide specific information to the disposal site (at time of site visit).

What is Treated Wood Waste?

Wood treated with a chemical preservative for protection against pests and environmental conditions is called treated wood. Treated wood that has reached the end of its usefulness is regarded as treated wood waste or TWW and can only be dropped off at permitted facilities or disposed of at composite-lined solid waste landfills.

Examples of TWW include:

✔ Fence posts

✓ Sill plates

✓ Decking

✓ Landscape timbers

✓ Pilings

✓ Guardrails

Disposal Process for Treated Wood Waste

It is the waste generator's responsibility to determine if the wood is hazardous waste and will be asked to provide specific information to the disposal site.

Treated Wood Waste Disposal: \$221.25 per ton

Please follow these steps when visiting Contra Costa Waste Services (RCTS):

- 1. Enter the Construction and Demolition Scale to the left after the first stop sign at the facility.
- 2. Notify the scale attendant you have Treated Wood Waste.
- **3.** The scale attendant will inspect your load and direct you where to dump it.

4. Complete the guick customer form and submit it to the scale while completing your transaction.

COMPOST BY BAG OR BULK

Bags: (1.5 cubic feet - 42.5 liters) \$10 per bag, plus tax*

Bulk: (1 ton – 2.22 cubic yards) \$70 plus tax, plus tax*

BARK BY BULK

Black bark: (colored - per ton) \$250 per ton, plus tax*

Natural bark (no colored added) \$200 per ton, plus tax*

ALL LOADS MUST BE COVERED: Per the City of Pittsburg's Municipal Code, Section 8.04.140, all vehicles transporting refuse within the City shall be completely covered to prevent spilling and blowing from a vehicle when on route to a disposal site. This is in accordance with State law, California Vehicle Code (CVC) Sections 23114 and 23115, which states it is against the law to operate a vehicle on the highway which is improperly covered, constructed, or loaded so that any part of its content or load spills, drops, leaks, blows or otherwise escapes from the vehicle. In addition, CVC 2011 states any vehicle transporting garbage, trash, or rubbish, used cans or bottles, waste papers, waste cardboard, etc. must have the load covered to prevent any part of the load from spilling on the highway. Significant fines are possible for non-compliance. Exempt materials include hay and straw, clear waste and feathers from live birds.
